## LIMITED RESIDENTIAL WARRANTY

When installation instructions are followed in their entirety, BlueZone® Perimeter Sealant Tape will prevent the damage to flooring from everyday household spills around the perimeter of a flooring installation.

BlueZone® Perimeter Sealant Tape comes with and is subject to the terms of this Lifetime Limited Residential Warranty. This Lifetime Limited Residential Warranty covers defects in material which relate to adhesive integrity and liquid resistance during normal everyday residential use when installation instructions are followed.

### Limited Lifetime Residential Warranty

**FEATURES WARRANTIED:** CalFlor Accessory Systems warrants BlueZone® Perimeter Sealant Tape against manufacturing defects as follows:

**Adhesive Integrity:** The adhesive on BlueZone® Perimeter Sealant Tape will not fail when exposed to normal residential use.

**Liquid Resistance:** BlueZone® Perimeter Sealant Tape will resist moisture penetration under normal use for the life of the product.

### General Terms and Conditions for the BlueZone® Perimeter Sealant Tape Limited Warranty

BlueZone® Perimeter Sealant Tape carries the specific warranties listed above which are subject to the following general terms and conditions:

1. This warranty applies to the person stated as the buyer on the purchase document(s) and only for residential, interior use. It does not extend to any subsequent owner or other transferee of the product. This limited warranty does not apply to any commercial or industrial use. This warranty applies only to first quality CalFlor brand product purchases made after the edition date of this warranty when the product is installed in an indoor, climate controlled, private residence and according to the manufacturer's installation instructions.
2. This warranty does not cover damage to the product caused by installation errors. BlueZone® Perimeter Sealant Tape must be inspected carefully for material defects or damage before and during installation and under sufficient lighting. Products with visible defects must not be installed under any circumstances. All installation rules and requirements must be followed when installing BlueZone® Perimeter Sealant Tape, including, but not limited to eliminating gaps within the tape line during application, applying only to dry, clean surfaces, and covering the tape with the appropriate moldings. BlueZone® Perimeter Sealant Tape is not intended for areas with direct exposure to foot traffic; cover with appropriate molding.

### LIMITED RESIDENTIAL WARRANTY

3. This warranty does not apply to damage from exposure to extreme heat due to steam cleaners and the like, or chemical or industrial cleaning products. The BlueZone® Perimeter Sealant Tape cannot be installed in damp and/or humid areas, or areas where there are extremely high temperatures (such as saunas or swimming pool areas).
4. The entire perimeter of the installation and all transitional moldings must be sealed with correctly installed BlueZone® Perimeter Sealant Tape. Any gaps in the application of the BlueZone® Perimeter Sealant Tape in the perimeter, at corners, or within any transitional moldings will invalidate all warranties, express or implied.
5. Concerning BlueZone® Perimeter Sealant Tape, for any material defects or failures to perform as stated, the manufacturer must be informed in writing of such defects within 30 days of the occurrence. After this time has elapsed, no further complaints will be accepted.

#### Limited Lifetime Residential Warranty

CalFlor Accessory Systems warrants BlueZone® Perimeter Sealant Tape will be free of defects in material and manufacture. CALFLOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, This warranty does not cover damage resulting from the misuse or application or storage not in accordance with recommended procedures. Important notice: Please remember that many factors can affect the use and performance of a tape product in a particular application. The materials to be bonded with the product, the surface preparation of these materials, the products selected for use, the conditions in which the product is used, and the time and environmental conditions in which the product is expected to perform are among the many factors that can affect the use and performance of a tape product.

**EXCLUSIONS:** This warranty is only available if the BlueZone® Perimeter Sealant Tape has been properly installed and is subject to normal indoor, residential use. Further, this warranty applies only to manufacturing defects, and does not cover (i) dusty or unclean or damp substrates, (ii) deterioration of tape caused by excessive moisture or alkali, or (iii) improper floor cleaning methods after installation.

This warranty does not apply to product that have been put to abnormal use or conditions or abused in any way, which includes, but is not limited to large spills or floods, appliance leaks, plumbing leaks/failures, storms, acidic liquids, corrosive materials or detergents; damage from smoke, fire or other casualty events; damage caused by negligence, improper alterations of the original manufactured product, damage of mechanical nature, or cutting; improper floor care maintenance or mopping with detergents; damage caused by moisture coming from routes other than the areas directly protected by BlueZone® including spills where the water leaks from the top of the flooring through the joints, moisture entering from other rooms, damage caused by water or moisture trapped beneath the BlueZone® Perimeter Sealant Tape due to improper subflooring or underlayment, including, but not limited to, damage from hydrostatic pressure or other conditions that result in water or moisture beneath the BlueZone® Perimeter Sealant Tape;

This Warranty covers the original purchaser of the CalFlor Accessory Systems BlueZone® Perimeter Sealant Tape at its original installation site(s). This warranty is not transferable. This warranty shall only be effective provided that the flooring the BlueZone® Perimeter Sealant Tape is intended to protect was installed and subsequently has been maintained in strict compliance with the procedures recommended by its manufacturer. EXCEPT AS SET FORTH HEREIN, THERE ARE NO EXPRESS WARRANTIES MADE BY CALFLOR ON THIS TAPE. THIS WARRANTY EXCLUDES ALL IMPLIED WARRANTIES, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE (some states do not allow the exclusion or limitation of implied

**REMEDIES:** CalFlor Accessory Systems, at its option, may designate a representative to inspect the tape system and/or have the tape system tested by an independent testing firm. If the inspection or independent testing reveals that the tape has not performed as warranted above, then CalFlor will, at its option, replace or refund that purchase price of the tape.
